

A Reorganization Meeting of the Parkside Borough Council was held at the Parkside Borough Office on the above date. The meeting was called to order at 7:00 p.m. by Mayor Thomas G. Deitman. Following the Pledge of Allegiance, the roll was called with the following in attendance:

At this time Mayor Deitman did swear-in the three new Council persons: Perry Sweigart, Anna Guy and Scott Sidlow.

Mayor Deitman did request nominations for Council President. Councilwoman Purcival made a motion, seconded by Councilman Capobianco to open the nominations for President of Council; motion carried.

Councilman Capobianco did nominate Shirley Purcival for Council President. A roll call vote was taken and Shirley Purcival was elected Council President by a unanimous vote.

Councilwoman Purcival made a motion, seconded by Councilman Capobianco to open nominations for Vice President of Council; motion carried.

Councilman Capobianco nominated Douglas Bull for Vice President of Council.

Councilman Sidlow nominated Councilwoman Guy for Vice President of Council.

The following roll call vote was taken: Votes for Councilman BULL – Bull, Sweigart,

Capobianco, Purcival, Long. Votes for Councilwoman GUY – Sidlow, Guy

Councilman Douglas Bull won by majority vote and is now the Parkside Borough Vice President.

At this time President Purcival did take control of the meeting and thanked everyone for their confidence and votes. She then announced appointments and Committees in accordance with the attached lists. Councilman Sidlow did indicate he did not want to Chair the Recreation Committee. He did not think that would be his strong point. He was not familiar with the procedure of how Committees are appointed. It was explained that the Council President is responsible for appointing Committees. He mentioned he will not head the Recreation Committee.

Councilman Capobianco made a motion, seconded by Vice President Bull, to adopt Resolution #1815 designating TDBank and Conestoga Bank as the depository for Borough Checking Accounts and the PENNSYLVANIA LOCAL GOVERNMENT INVESTMENT TRUST (PLGIT) at the depository for Borough Savings Account; motion carried.

Councilman Capobianco made a motion, seconded by Vice President Bull, to adopt Resolution #1816 designating PRIME PAY to handle Borough payroll; motion carried.
